## **Huber Airpark HOA Meeting Minutes**

The meeting was called to order at 6:10 P.M. on June 3, 2015

Al Andrews opened the meeting and the following items were discussed:

- 1. Chuck Woods gave a summary of the meeting that he, Joe Power and Joe Hudson had with Grace G. Kunde, Attorney At Law, concerning the 2/3 HOA member approval requirements in accordance with the "Declaration Of Covenants, Conditions And Restrictions Huber Air Park Subdivision" to proceed with the runway project as recommended by the runway committee. The attorney's opinion was that a 2/3 HOA member approval for making the improvements to the runway was within the Board of Directors authority to make the necessary special assessment for each lot.
- 2. Dr. Irvin Sahni brought up the issue of water retention on the West side of the runway. He stated that his hanger was very close to having water enter his hanger during the previous weeks of rain in the area and was concerned that the additional asphalt on the runway may increase the amount of water running off the runway. With the excavation work that is planned for the East side of the runway and the end result of the runway work to be completed, the consensus was that the drainage problem would be improved. It was also stated that a committee would be formed in the very near future to address water drainage issues on the West side of the runway tasked with making recommendations to address the issue.
- 3. Derrick Smith verified that the result of the Proxy Vote was approved by the HOA membership by a margin of 87% to proceed with the runway improvement project.
- 4. Motion made by Chuck Woods to notify the HOA membership of a special assessment of \$9250.00 for each lot payable no later than June 30, 2015 in order to have all the necessary funds available to proceed with the runway project. Al Andrews seconded the motion and all board member's present approved.
